## OKLAHOMA STATE TREASURER

May 23, 2013

To the People of Oklahoma:

I am pleased to issue the April monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

### Market Conditions

US Treasury yields were all down for the month of March. Since prices and yields move inversely, the price increases meant yields decreased. The yield on the 10-year Treasury note fell to the lowest level this year, 1.67%. The Dow Jones Industrial Average (DJIA) finished the month up 1.8%, which was the fifth consecutive month of gains. The S&P 500 finished April with a 1.8% gain, which was the sixth monthly advance and the NASDAQ Composite Index was up 1.9%. The Federal Open Market Committee (FOMC) said it will continue its monthly bond buying at a pace of \$85 billion. The FOMC plans to sustain its target interest rate near zero as long as unemployment remains above 6.5% and the outlook for inflation does not exceed 2.5%.

### Economic Developments

Numerous reports were issued in April that affected performance of the markets during the month. The Institute for Supply Management reported that its index of manufacturing activity was 51.3 in March, down from 54.2 in February. This is the fourth consecutive month above a 50 reading. A reading over 50 represents growth or expansion within the manufacturing sector of the economy. The index reversed much of the gains from January and February. The March unemployment rate fell to 7.6% as only 88,000 jobs were added. Hours worked increased so average weekly earnings were up 2.1% from a year ago. The producer price index (PPI) for finished goods fell 0.6% in March with energy prices plunging 3.4%. Retail sales fell 0.4% in March. Gas stations saw the biggest decline in sales, down 2.2%, electronics fell 1.6% and there was a 0.8% drop in sporting goods. The consumer price index (CPI) fell 0.2% in March, as it was also affected by falling energy prices. The year-over-year increase in the CPI is now only 1.5%. The trade deficit narrowed to \$47.39 billion from \$48.07 billion in February, as exports rose 0.8% while imports were unchanged. The Leading Economic Indicators Index declined 0.1% in March. The Conference Board's consumer confidence index rose to 68.1 in April from 61.9 the prior month. Gross domestic product (GDP) for the first quarter of 2013 reported headline growth of only 2.5%, following a meager 0.4% growth in the fourth quarter of 2012. Housing starts rose 7% in March, topping one million for the first time since the financial crisis. Existing home sales fell 0.6% in March, but sales were up 10.3% from a year earlier. The existing median home price rose 11.8% in March from the prior year of \$184,300. Of the homes sold, 37% were listed less than one month. The Commerce Department reported new home sales increased 1.5% in March from the prior month to an annual rate of 417,000. The median new home sale price rose 3% year-over-year to \$247,000. Homeownership fell during the first quarter to 65%, reaching its lowest level since 1995. Prices of gold and silver were down 16% and 23%, while copper was down 13%.

### Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 2.02% in April and the weighted average maturity was 970 days. Money market fund balances increased due to the receipt of income taxes. The year-to-date monthly average investable base was \$3.861 billion. Portfolio diversification continues to be sound. U.S. Treasury Inflation-Protected Securities represented 1% of holdings, and U.S. government sponsored enterprises accounted for approximately 36% of the portfolio. Mortgage-backed securities were 41%, municipal bonds were 2% and Certificates of Deposit represented 2% of assets. Money market mutual funds were 13%, and the allocable portion of sales and use tax to General Revenue collected by the Oklahoma Tax Commission was 3%. State Bond Issues (at 2%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Based on challenging and potentially volatile market conditions, portfolio strategy consists of a combination of laddered maturities and market observation for investment opportunities that will maximize income in a secure environment.

### Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

### Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees and mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

### Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$4,006,880,154 and State Agency balances in OK Invest at \$2,476,135,241 for a total of \$6,483,015,394.



In February 2012, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2013. The amount estimated was \$83,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

# Explanation of Performance Comparison

## April 30, 2013

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



**NOTE:** Pursuant to Oklahoma State Statute Title 62, Section 89.7, all known fees are to be reported. The money market mutual fund fees reported above are shown at the contracted rate. Due to the current low interest rate environment, a portion of these fees have been voluntarily waived by the provider. An adjustment to actual fees will be presented in the Annual Report.

The State Treasurer participates in a Securitiet Lending Program with J. P. Morgan Chase & Co. acting as lending agent. J. P. Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$3,950.99. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
