To the People of Oklahoma:

I am pleased to issue the May monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

The crisis in Europe was the dominant influence on the U.S. bond market in May. Flight to safety by global investors pushed yields on U.S. Treasuries to record lows late in the month. The yield curve flattened 50 basis points in the month due to overseas chaos. The Dow Jones Industrial Average (DJIA) fell 6.2% for the month, its biggest monthly retreat since a 7.9% drop in May 2010. The Standard and Poor's 500-stock index fell 6.3% and the Nasdaq 7.2% in May. Disappointment with American economic reports and concern about Europe's debt crisis sent markets lower. The Federal Open Market Committee (FOMC) announced changes to their meeting schedule. Going forward, all meetings will be two-day meetings and they changed the schedule when they would release their Summary of Economic Projections (SEPs) and hold press conferences. These will now occur at the final meeting of each quarter.

Economic Developments

Numerous reports were issued in May that affected performance of the markets during the month. The Institute for Supply Management reported that its index of manufacturing activity rose to 54.8 in April from 53.4 in March, the highest since June 2011. The unemployment rate fell to 8.1% in April from 8.2% in March due to a sharp drop in the labor force. Average hourly earnings were unchanged in April and rose just 1.8% year-over-year. The workweek was unchanged at 34.5 hours. The producer price index (PPI) for finished goods fell 0.2% in April, resulting in a year-over-year increase for the index of 1.9%. This was the lowest rate of change since October 2009. The drop was due largely to a 3.1% decline in natural gas and a 1.7% drop in gasoline. This was the second consecutive decline in gasoline prices following a sharp rise in January and February. Retail sales rose 0.1% in April following an impressive 0.7% increase at the end of the first quarter. The consumer price index (CPI) was unchanged in April and up 2.3% year-over-year. The Commerce Department reported the trade deficit widened to \$51.8 billion in March due to higher demand for imports. The Conference Board's consumer confidence index fell to 64.9 in May, a four-month low. It was down from 68.7 in April. Gross domestic product (GDP) growth in the first quarter was revised from 2.2% to 1.9%, in line with economists' expectations that the U.S. economy slowed more than initially thought. Existing home sales rose 3.4% in April. This is the first increase in existing home sales in three months. Nationwide, homes priced between \$250,000 and \$500,000 were up 21.1% from a year earlier. New home sales rose 3.3% in April, better than expected. The median price for a new home in April was \$235,700, up slightly from March and nearly 5% higher compared with a year earlier. Only 46,000 new homes were completed in April, the lowest number on record.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 2.34% in May and the weighted average maturity was 1,071 days. With regard to weightings, funds were shifted out of money market mutual funds and into mortgage-backed securities and U.S. government sponsored enterprises. The year-to-date monthly average investable base increased to \$3.440 billion in May. Portfolio diversification continues to be sound. U.S. government sponsored enterprises accounted for approximately 39% of the portfolio. Mortgage-backed securities were 41%, municipal bonds were 2% and Certificates of Deposit represented 4% of assets. Money market mutual funds were 7% and the allocable portion of sales and use tax to General Revenue collected by the Oklahoma Tax Commission was 4% of assets. State Bond Issues (at 2%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Based on challenging and potentially volatile market conditions, portfolio strategy consists of a combination of laddered maturities and market observation for investment opportunities that will maximize income in a secure environment.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees and mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$3,491,402,139 and State Agency balances in OK Invest at \$2,257,242,919 for a total of \$5,748,645,058.



In December 2011, the Treasurer adjusted estimated earnings to the Board of Equalization for Fiscal Year 2012. The amount estimated was changed to \$80,000,000 from \$96,000,000. Fiscal Year to Date Revenue estimates reflect this revised estimate. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison

May 31, 2012

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



The State Treasurer participates in a Securities Lending Program with J. P. Morgan Chase & Co. acting as lending agent. J. P. Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$3,897.98. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
